Google Analytics

Kids In Sport Inc. has implemented Google Analytics on our website. Visitors can opt-out of Google Analytics by downloading and installing the Google Analytics Opt-out Browser Add-on. This add-on instructs the Google Analytics JavaScript running on websites to prohibit sending information to Google Analytics. The data collected with Google Analytics will help us determine who is visiting our website and in turn, help us to better serve and understand our customers.
